# Copyright Policy for the International Journal of Management Perspectives (IJMP)

# 1. Copyright Ownership

- Upon acceptance for publication, authors are required to transfer copyright of their manuscripts to the International Journal of Management Perspectives (IJMP). This copyright transfer grants the journal exclusive rights to publish, reproduce, and distribute the work in any form and medium, both now and in the future.
- This transfer of copyright is intended to facilitate the widest dissemination of the research, ensuring that the journal maintains control over how the work is shared, while upholding the authors' rights to use their own work.

#### 2. Author Rights

- Although copyright is transferred to the journal, authors retain the following rights to their work:
  - **Reuse in Scholarly Work**: Authors may use all or part of their published work in future scholarly publications, such as books, dissertations, and conference presentations, with appropriate attribution to the original journal publication.
